- Harvest weed seed management – WA and local experience – does it have a role in future farming systems in NWNSW?
- Getting best performance from pre-emergent herbicides
- Using multiple weed management tactics in a farming system
- Non-herbicide based tactics - crop competition, weed seed capture - what is achievable?
